-  **2.1 Personal Identifiable Information (PII):** While bitcoinbsc.io does not inherently collect PII such as names, addresses, or emails, there are occasions, such as communications with our support team or query submissions, where such details might be provided by the user.
-  **2.2 Blockchain Data:** Transactions and wallet addresses associated with the Binance Chain are public by nature. However, these details do not directly divulge personal identities.
-  **2.3 Usage Data:** This comprises data related to user interaction with our token, which can include the frequency and size of transactions.





# 3. INFORMATION UTILISATION



We use the collected data for:

- 3.1** Cookies: User and device information, to provide Essential, Performance and Functional features of the website.
- 3.2** Token Enhancement: Usage data assists us in comprehending how our community engages with our token, guiding improvements.
- 3.3** Communication: If users offer contact information, it may be employed for correspondence regarding their inquiries or to provide updates.

- 4.1** Binance Chain Publicity: All transactions on the Binance Chain can be viewed publicly by anyone with access.
- 4.2** Regulatory Compliance: Should legal, regulatory, or court orders necessitate it, bitcoinbsc.io may be compelled to disclose certain information.
- 4.3** Prohibition of Personal Data Sales: We do not engage in the sale of personal data to third parties.

It is pertinent to note that Binance Chain transactions benefit from the intrinsic security of the platform, while the security of your wallet largely depends on individual user practices.
